to Mortgage" are deleted.

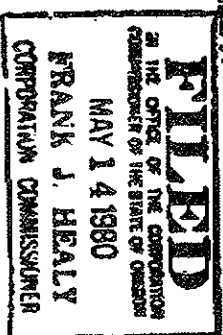
III.
