AMENDMENT NO. 2 TO CONDOMINIUM DECLARATION
FOR
THE GARDEN COURT ON BELMONT

THIS AMENDMENT NO. 2 TO CONDOMINIUM DECLARATION FOR THE GARDEN COURT ON BELMONT is made as of this 29th day of September, 1995, by The Belmont Ridge Limited Partnership, a Washington limited partnership, in its capacity as "Declarant" under that certain Condominium Declaration for The Garden Court on Belmont recorded in Real Property Records of King County, Washington, under Recording No. 9504070248, together with all amendments thereto (collectively, the "Declaration"). All capitalized terms not defined in this Amendment No. 2 shall have the meaning given in the Declaration. First Amendment Recording #9504251615.

Declarant is the owner of all Units created by the Declaration and accordingly has full power and authority to amend the Declaration as set forth herein. The Declarant wishes to amend the Declaration to reflect parking stall and storage unit assignments negotiated with prospective purchasers of the Units. No other amendments to the Declaration are contemplated by this Amendment No. 2.

1. Amendment. The Declaration is hereby amended by deleting Schedule B thereto and substituting in its place Schedule B attached to this Amendment No. 2. The sole amendment to Schedule B is to change parking stall and storage unit assignments to comport with Declarant's commitments to Unit purchasers. Except as amended hereby, the Declaration remains in full force and effect in accordance with its terms.
